Did then and there commit the offense of **TERRORISTIC THREAT (PC 22.07.) CLASS B Misdemeanor**, by threatening to commit an offense involving violence to person, namely, hanging, with intent to cause a reaction of any type to his threat by an official or volunteer agency organized to deal with emergencies Wilson County Sheriff's Office and the Constable's Office; place any person in fear of imminent serious bodily injury to wit: threaten to hang the victim's Pastor Frank Pomeroy and Rod Green.

And as probable cause for this belief and for an arrest warrant would show the following. On 3-5-2018, WCSO units were dispatched to the First Baptist Church of Sutherland Springs for a disturbance. Deputies arrived and took the actor into custody for criminal trespass. Statements were taken from both Pastor Frank Pomeroy and Rod Green. In their statements the victims claimed the actor threatened to hang them. Both victims were in fear of their personal safety by the verbal threats and demeanor.
