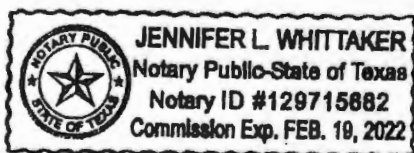
Before me, the undersigned notary, on this day personally appeared MIA PIEDRA, the affiant whose identity is known to me. After I administered an oath affiant testified as follows:


